The Cattaraugus County Agricultural Society is getting ready to celebrate our 168th Cattaraugus County Fair. Fair dates for this year are August 2 – August 8, 2010. Please note that the fair has moved back an entire week to be in succession with the NY State Fair. Our fair has grown over the years to be a great county fair. In fact, our fair in is the top ten of fifty four fairs in New York State concerning attendance! Last year, 73,000 people came through the gates to enjoy vendors like you!

If your 2010 deposit was not 50% of the total balance, please send any additional money owed. **ALL VENDORS MUST INCLUDE A PICTURE (preferred) OR A DETAILED DESCRIPTION OF HOW THE WARES ARE DISPLAYED. ALL VENDORS MUST ALSO INCLUDE A DETAILED MENU OR LIST OF ITEMS THAT WILL BE SOLD DURING THE WEEK. PLEASE, BE SPECIFIC!!!!**

Also enclosed is a contract to advertise in our Fair Premium Book. This is an idea that many of our vendors have used in the past to tell patrons that they will be at our fair in 2010. This is completely optional but recommended. *Become a corporate sponsor and receive a personalized sign for your vendor space! It allows everyone to know you support the fair as a Corporate Sponsor! Contract is enclosed.*

Each vendor is allotted 2 passes with each contract. Please note additional rules listed on your contract. No children (15 & under) will be permitted to use a vendor pass to enter the gate. **ABSOLUTELY NO LISTS WILL BE USED AT ANY GATE TO PERMIT VENDORS ON TO THE FAIRGROUNDS.** Everyone working must have a pass to enter the grounds. Reminder – no one working a vendor space should be consuming alcohol.

We are asking that each Vendor be in their allotted space by 12:00 PM on Monday the first day of the Fair. Anyone who is not in their vendor space at this time will relinquish their vendor space. Any deliveries are to be made by 11:00 AM each day. This will be strictly enforced as we have a great number of people on the grounds by that time.

The area allotted is at the discretion of the fair office. Spaces are determined, first by number of years attended and second, by type of product. Spaces are not negotiable.

Vendors will receive their packet at the Front gate office. There it will be explained what you must have when you come in the gate daily. Everyone needs a pass in order to be allowed in the gate. NOTE:

Please return one copy of the signed contract by April 1, 2010, along with your check for 50% of the total amount due. This is a non-refundable deposit. The balance is due by July 1, 2010. **Contracts will not be accepted without a signature and deposit.**

No concession will be allowed to leave the grounds before the end of the Fair. Any vendor leaving the grounds prior to the end of the Fair will lose all future concession rights.

No consumption of alcoholic beverage is allowed by anyone working a vendor space at ANY time he or she is working. You are a representative of the fair.

COCA -COLA of Buffalo has exclusive pouring rights on the Fairgrounds. A representative from COCA-COLA will be on the grounds. 20 oz. bottles must be used while vending at the event. YOU MUST USE OUR COCA-COLA DISTRIBUTOR! If any other product is used, the vendor will be asked to leave. A "Certificate of Insurance" and "Certificate of Authority" must be presented prior to occupying your booth or lot.
